"I've been issued a citation, now what do I do?"

- If appearance before the Judge is **NOT** required, and you wish to **plead guilty**:
 1. **sign the back of your yellow ticket AND**
 2. mail it with your payment to: PO Box 187, Willard, MO
 3. **OR pay in person:** bring your payment & signed ticket to Willard City Hall / Violations Bureau
224 W. Jackson, **8am – 5pm**, Monday through Friday.

NEW!

If you have been charged with "**No insurance/No Proof of Insurance**", and you simply did not have the **PROOF** with you, you are allowed to bring your proof of insurance to the court clerk at City Hall **BEFORE** your scheduled court date. She will copy the information and submit it to the Prosecuting Attorney for review and possible dismissal. If the P.A. has a concern with the information, you may be issued a summons to appear on the original charge at the next scheduled court date.

Dismissal is at the discretion of the judge and/or prosecutor.

- The following payment methods are accepted:
 1. Check~Cash~Money Order~ Debit/Credit Card (MC or Visa only)
 2. Make check payable to:
City of Willard and include the yellow ticket
(Defendant must sign back of ticket).
- All returned checks will be charged \$30.00 and charges may be filed.
- You are **REQUIRED** to appear before the Judge on the following:
 1. **ANY violation resulting in personal injury/property damage (auto accidents);**
 2. **Alcohol or Drug violations;**
 3. **Operating a vehicle with counterfeited, altered, suspended or revoked license;**
 4. **Fleeing or attempting to elude an officer;**
 5. **AND ANY OTHER VIOLATION THE JUDGE ORDERS.**
- **YOUR COURT DATE IS ON THE TICKET – APPEARANCE TIME IS ALWAYS 2:00PM ON THAT DATE.**
 1. Court is in session until last case is heard.

**IF YOU DO NOT APPEAR AND DO NOT PAY BEFORE YOUR COURT DATE (IF ALLOWED),
YOUR LICENSE MAY BE SUSPENDED AND/OR WARRANT ISSUED FOR YOUR ARREST.**
