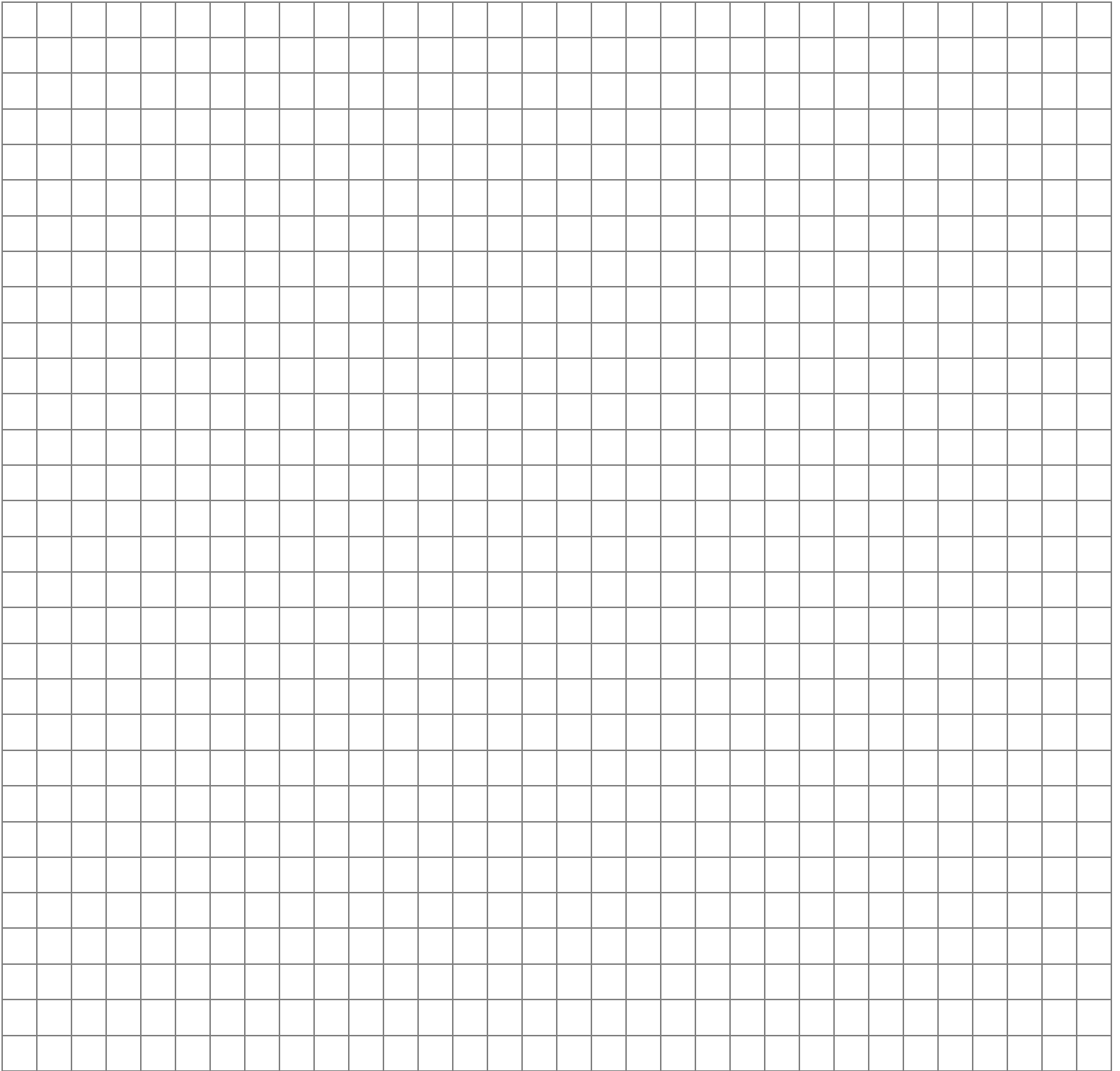

Inspections:

Inspections are performed by the City of Willard. Please allow a 24-hour notice for all inspections.

- Site inspection after the tent is erected
- Final inspection after product placement
- Temporary power inspection
