## CHECKLIST SKETCH PLAN FOR MINOR/MAJOR SUBDIVISION City of Willard, Missouri

The application must be complete and all items listed on the checklist must accompany the application or this case will not be processed. The application must be submitted no later than 4:00 p.m. to the Willard City Hall, 15 working days prior to the Planning and Zoning Commission meeting at which the sketch plan will be considered. Contact the City Clerk at the telephone number below for filing deadlines and meeting dates.

PRE-APPLICATION CONFERENCE:  Although not required, the applicant is encouraged to discuss the proposed subdivision with City staff prior to submitting the sketch plan. City staff may inform the applicant of any particular concerns that should be addressed in the sketch plan.

Submit eight (8) copies of a sketch plan on 11'x17'sheet size paper. Applicant must also	
submit three (3) copies on 24"x36" sheet size paper. The sketch plan is to be drawn to an	
approximate scale of $1'' = 100'$ and contain the following information:	
A. Name and address of the property owner/developer.	
B. Tract boundary and principal features within 1000 feet.	
C. Proposed name of the subdivision	
D. Location of subdivision by township, range and section.	
E. Approximate north arrow and scale.	
F. Approximate total acreage of the subdivision.	
G. Existing streets on and adjacent to the tract, including width of rights-of-way.	
H. Tentative street and lot arrangement.	
I. Existing utilities.	
J. Existing drainage ways.	
K. Unique topographical and physical features.	
APPLICATION FEE:

Note: The Planning and Zoning Commission <u>shall not</u> take action on the sketch plan when the applicant or the applicant's agent does not appear at the Commission meeting to provide evidence regarding the sketch plan for the proposed subdivision.
